Weston-super-Mare Beach Race – 10 & 11 October 2009

TERMS AND CONDITIONS – TRADE / EXHIBITORS

All Traders / Exhibitors must be on site by 12 noon on Friday 9th October 2009 latest.

No Vehicles will be allowed to enter the event site after 0800, thereafter departing no earlier than 1800 on the event days 10/11 October, 2009.

All trader / exhibitor event passes will **not be** despatched in advance of the 'race' this year. These documents will need to be collected from the WBR 'Welcome Centre' **Opening Hours 1000-1800 Thursday 08/10 and 0700/1000 Friday 09/10.**

The office will be situated at the Weston Beach Site .
Full details will follow nearer the event.

Requirements will include a recent photograph of the relevant 'Pass Holder' (passport size) together with your vehicle details to include 'make/model and registration number.

The Trader/ Exhibitor will at the time of Submitting their booking confirm that they possess valid insurance – both Public Liability minimum of 5 Million Pounds and Product. These documents must be 'current' and available for inspection on the 9/10/11 October 2009.

The Trader / Exhibitor must provide a comprehensive **Risk Assessment / Method Statement** appertaining to the construction, dismantling and operation of the trade unit / stall proposed for use on a site (please note a sea front location). This document/s should identify the build method for the unit or structure and indicate the company / persons carrying out the construction along with their competency. The structure should be 'appropriately weighted' to remain fixed at all times.

Provisions should be included in the document to cover the safety and welfare of staff of the promoting company (including its servants and agents),

members of the Emergency Services and the general public.

All trade / exhibitor stands will be located in a large marquee on the Beach Lawns. All trading must therefore be undertaken within the marquee provided.

This is a **Health and Safety** requirement and must be strictly adhered to. Any trader found to be in contravention of this requirement will be removed from site.

All **TRADE / EXHIBITOR STAND BOOKINGS** must be accompanied by a 30% deposit. Spaces are limited and are therefore allocated on a strictly 'receipt of signed order' basis. All reservations must be paid in full (cleared funds) by the dates indicated on the company's official event booking form to secure. Failure to comply will unfortunately result in the 'space' being resold and subsequent loss of deposit.

Traders/ Exhibitors please note – any damage to the area of the trade marquee hired to you under this agreement will be re-charged accordingly. On arrival onsite therefore please check your location thoroughly recording any damage with the event organisers.

Sub-letting or licensing the use of stand space, is not permitted under any circumstance whatsoever. Neither may the products of services of companies not trading in their own right be promoted or displayed on the event site. Forfeiture of all monies paid to the company and removal of all personnel, equipment and stock from the site will follow, if such action is undertaken without the express written agreement of the event organisers
